- (iv) The Administrator shall facilitate and discharge his duties and obligations as laid down in Byelaws of the Society.
- (v) The Administrator shall take over proper charge of the Society.
- (vi) The Administrator shall submit monthly report to the Registrar Cooperative Societies, Islamabad regarding affairs of the Society.

3. The Administrator may withdraw remuneration @ Rs.10,000/- per month as per policy.
