Rawalpindi, the 12th December, 2022

S. R. O. 2276(I)/2022.—In pursuance of sub-rule (2) of Rule-3 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, and Section 7(1) (b) (i) and (ii) of FPSC, 1977 (XLV of 1977), the following amendments shall be made in the Recruitment Rules for the posts in Pakistan Navy under Ministry of Defence, notified *vide* S.R.O 4(KE)/96, dated 05-11-1995, namely:—

In the aforesaid Recruitment Rules;

- a. In Rule-2 (**Method of appointment**) under the caption, “Miscellaneous” aforesaid Recruitment Rules, against the post of Fire Officer (BPS-16) at S.No.48, the existing entries under columns (3) and (4) shall be substituted with “50%” and “50%”, respectively.
- b. In Rule-3 (**Conditions for promotion**) of aforesaid Recruitment Rules, under the heading “Miscellaneous” against the post at S. No. 47, the existing entries under columns (3) and (4) shall be replaced with the following:—

OR

B.S.(Physical Sciences/Applied Sciences) from University recognized by the HEC.

OR

- i. DAE (Mechanical/Electrical/Construction/Civil) from a recognized Institution with 02 years' experience in relevant field including Fire Fighting/Management Services.
- ii. One year certificate in Fire Fighting.
