The office of Deputy Commissioner, ICT has held the position of Registrar Cooperative Societies office since 1981. From 23rd March 2014 to 8th May 2018 the position of Registrar Cooperative Societies was held by the office of Director (Div/Finance). This Notification intends for the Deputy Commissioner, ICT to resume holding the office of Registrar, Cooperative Societies, ICT under all relevant laws, rules and enabling provisions mentioned hereinbefore.”SS
