NOTIFICATION

Islamabad, the 1st December, 2021

S.R.O.1573 (I)/2021.—In exercise of the powers conferred by Articles 90 and 99 of the Constitution of the Islamic Republic of Pakistan, the Federal Government is pleased to direct that in the Rules of Business, 1973, the following further amendments shall be made, namely: —

In the aforesaid Rules,—

(1) after rule 50, the following new rule shall be inserted, namely:—

“50A. **Secretariat of Council of Common Interests.**—(1) There shall be a Secretariat of the Council of Common Interests (SCCI), having status of a Division which shall be headed by the Secretary to the Council of Common Interests.

- (2) The Secretary of the Council shall report directly to the Prime Minister, in the latter's capacity as Chairman, CCI and shall also function as principal accounting officer of the Secretariat.
- (3) The procedure for conduct of business of the Council of Common Interests shall be governed in terms of the Rules of Procedure of the Council of Common Interests, 2010.”;

(2) in Schedule II, —

(a) in item 2, entries 72 and 79 shall be omitted;

(b) in item 6, for entries 6 and 7, the following shall be substituted, namely:-

“6. Postal Services and Postal Life Insurance Company Limited.

7. (i) services provided on behalf of the Federal Government and Provincial Governments;

(ii) agency functions on behalf of agency alliances and partnerships with corporate entities under regulatory regime of the Government such as the State Bank of Pakistan and the Securities and Exchange Commission of Pakistan, etc.;

8. Establish, regulate specialized entities in logistic and freight.”;

(c) in item 11, entry 25 shall be omitted;

(d) in item 12, in entry 11, in sub-entry (ii), the word “and” at the end shall be omitted and in sub-entry (iii) for the fullstop at the end a semi-colon and word “and” shall be substituted and thereafter the following new sub-entry shall be added, namely:—

“(iv) business related to the Federal Government Properties Management Authority (FGPMA).”;

(e) in item 14, entry 9 shall be omitted;

(f) in item 19, entry 4 shall be omitted;

(g) in item 23, for entry 22, the following shall be substituted, namely:-

“22. Pakistan Oil-seed Department.”;

(h) in item 25,-

(i) for entry 4, the following shall be substituted, namely:-

“4. Urdu Dictionary Board and Urdu Science Board.”;

(ii) after entry 17, the following new entry shall be added, namely:—

“18. Aiwan-e-Quaid Building.”; and

(3) in Schedule III, in column(1), —

(i) S. No. 31 and entry relating thereto in column (2) shall be omitted; and

(ii) against S. No. 38, for the entry in column (2), the words “National Information Technology Board” shall be substituted.
