No.2-2/2023-Min.I.— In exercise of the powers conferred by third proviso to clause (1A) of Article 224 of the Constitution of the Islamic Republic of Pakistan, the President, on the advice of the Prime Minister, has been pleased to appoint **Dr. Kauser Abdulla Malik** as care-taker Federal Minister. He will hold the portfolio of National Food Security and Research Division as allocated by the Prime Minister, in terms of rule 3(4) of the Rules of Business, 1973, with immediate effect.

2. **Dr. Kauser Abdulla Malik** has been administered the oath of office by the President today, the 11th September, 2023.
