No. F.2(2)/2022-LGE-B(VoI-IV)(1).—In exercise of the powers conferred upon it under Articles 140A(2) and 219(d) of the Constitution of the Islamic Republic of Pakistan, Section-219 of the Elections Act, 2017, Sections-16(1) & 36 of the Balochistan Local Government Act, 2010 read with Rule-9 of the Balochistan Local Government (Election) Rules, 2013 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby fixes **12th October, 2023 (Thursday)** as the date for administration of oath to the elected members as well as elections of Chairman & Vice-Chairman of the Union Council No.31, District Hub of Balochistan Province.

No. F. 2(2)/2022-LGE-B(Vol-IV)(2).—In exercise of the powers conferred upon it under Articles 140A(2) of the Constitution of the Islamic Republic of Pakistan, Section 19 of the Balochistan Local Government Act, 2010 read with Rule 10 of the Balochistan Local Government (Election) Rules, 2013, the Election Commission of Pakistan hereby appoints the following officer as Returning Officer/Presiding Officer for the administration of Oath and conduct of elections to the seats of Chairman & Vice-Chairman of Union Councils No.31 District Hub of Balochistan Province;

No. F. 2(2)/2022-LGE-B (Vol-IV)(3).—In exercise of the powers conferred upon it under Articles 140A (2) & 218(3) of the Constitution of the Islamic Republic of Pakistan read with Sections-6 & 193 of the Elections Act, 2017, the Election Commission of Pakistan hereby authorizes the Returning Officer/Presiding Officer, appointed for conduct of election to the seats of Chairman / Vice-Chairman of Union Council No.31, District Hub of Balochistan Province, scheduled to be held on 12-10-2023 to exercise the powers of the Magistrate First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) for two days *i.e* 11th & 12th October, 2023.

2. The aforesaid officer shall exercise the powers of Magistrate First Class under Section-193(a) of the Elections Act, 2017, Chapter-IV of the Balochistan Local Government (Elections) Act, 2010 except the offence of corrupt practice provided in Section-46 of the *ibid* Act. These offences shall be tried summarily in terms of Section-193(b) of Elections Act, 2017, under the provisions of the Code of Criminal Procedure, 1898 (Act No.V of 1898).
