SUBJECT:—SECHEDULE FOR THE IN-HOUSE ELECTION OF VC-12 ALIZAI AND VC-09 LAS GARHI OF KOHAT DISTRICT

No. F.27(1)/2023-LGE-KP.—In exercise of the powers conferred upon it under Article 140A(2) of the Constitution of the Islamic Republic of Pakistan, sub-section (1) of Sections-75 and 86 of the Khyber Pakhtunkhwa Local Government Act 2013, read with Rule-52(6) of the Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules 2021, and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby fixes **22nd November, 2023 (Wednesday)** as the date for the conduct of In-House Election to the seats of Chairmen of Village Council-09 Las Garhi, Tehsil Darra Adam Khel & Village Council-12 Alizai Tehsil Kohat of Kohat District and calls upon the Members/Electoral College to elect Chairmen of the Councils.

The Returning Officers (RO) appointed *vide* this Commission Notification **No.F.27(1)/2023-LGE-KP dated 17-11-2023** shall call meeting of Councils and inform all the Members of the concerned Council before election day, clearly intimating the date, time and place of the meeting.
