NOTIFICATION

Islamabad, the 30th November, 2023

S. R. O. 1785(I)/2023.— In exercise of the powers conferred by Sections 13(K), 26 (c)(iii) and 55(q) of the Legal Practitioners & Bar Councils Act, 1973 (XXXV of 1973) and all other enabling provisions in this behalf, the Pakistan Bar Council hereby makes and notifies the following amendments in the “*Pakistan Bar Council Legal Education Rules, 2015*”:

(1) **Short title and commencement:**

- (i) These Rules may be called the “Pakistan Bar Council Legal Education (Third Amendment), Rules, 2023”.
- (ii) They shall come into force at once.

(2) **Amendment in First Schedule under Rule 15(i):**

- (a) *The name of following Foreign University having been recognized by the Pakistan Bar Council, may be added in the list of Foreign Universities, in para (2) of First Schedule, under Rule 15 at Sr. (xv) under No.7.*

(3) **Amendment in Second Schedule under Rule 15(ii):**

- (b) The names of following Pakistani Universities having been recognized by the Pakistan Bar Council, may be added in the list of Pakistani Universities/Colleges/Degree Awarding Institutions, in para (1) of Second Schedule, under Rule 15(ii) after Sr. No.32.

“33. *The University of Chenab, Gujrat.*
(Provisional for one year w.e.f. 29-08-2023)”.

“34. *Grand Asian University, Sialkot.*
(Provisional for one year w.e.f. 29.08.2023)”.

“35. *Ghazi National Institute of Engineering & Sciences, Dera Ghazi Khan.*
(Provisional for one year w.e.f. 29-08-2023)”.

“36. *University of Chakwal, Chakwal.*
(Provisional for one year w.e.f. 29-08-2023)”.

(4) **Amendment in Rule 16**

In clause (ii) of Rule 16, the signs and figure “25,000/- (Rupees Twenty Five Thousand only)”, may be substituted by the signs and figure “40,000/- (Rupees Forty Thousand only)”.
