2. Scope/areas of each Sectoral Committee is as under:

3. Terms of Reference (ToRs) of the Sectoral Committees are as under:

- a) To deliberate each sector in detail;
- b) To indicate potential with respect to export, import substitution & value addition of each sector/chapter;
- c) To collect the existing facts & figures about each Sector and suggest measures for its improvement;
- d) To indicate the issues/impediments and give concrete recommendations for the approval of Industrial Advisory Council;
- e) Prepare a separate draft chapter of each sector;
- f) Present the draft to the Secretary, MoI&P for his approval; and
- g) Forward the final/approved draft (hard/soft) to IF Wing within 15 working days;
- h) Chairman of the Committee can Co-opt any Member of the sector concerned.
- i) Any other issue with the consensus of the Committee.
