*Islamabad, the 5th March, 2024*

**S. R. O. 368(I)/2024.**— In pursuance of sub-section (2,3&5) of Rule 2 of the Civil Servants (Appointment, Promotion & Transfer) Rules, 1973 read with the Gilgit-Baltistan Council Civil Servants (Adaptation) Act, 2010, the following amendments shall be made in the Recruitment Rules of Gilgit-Baltistan Council notified vide S.R.O. No. 175(I)/2011, dated 24-02-2011, namely: —

In the aforesaid Recruitment Rules:-

- (i) In rule 2 (**Method of Appointment**), against Sr.No.9 under column 4 the existing entry shall be deleted and substituted by “**50%**” and in column 5 the existing entry shall be deleted and substituted by “**50%**”.
- (ii) In rule 3 (**Condition for Promotion**), against Sr. No.5 under column 3 the existing entry “**BS-07**” shall be deleted and substituted by “**BS-10**” and in column 4 the word “**Matriculation**” shall be substituted with “**Intermediate/ equivalent**”.
- (iii) In rule 3, under column 4 after the word “**Matriculation with 30 WPM typing speed**”, the following shall be added in column 3:-

- (a) 50% promotion quota will be filled on the basis of seniority-cum-fitness, from amongst Naib Qasids, Chowkidars, Sweepers, Duplicate Machine Operator (DMO), Dispatch Rider (DR) and Drivers including holders of other equivalent posts in BS-10 and below with two years service as such. who have passed FA/F.Sc Examination or its equivalent qualification from a recognized Board.
- (b) For the purpose of promotion, there shall be maintained a common seniority list of Naib Qasids, Chowkidars, Sweepers, Duplicate Machine Operator (DMO), Dispatch Rider (DR) and Drivers etc.
- (c) Where a senior official does not meet the requisite conditions of eligibility for promotion at the time of filling up a vacancy, the official next junior to him if meet the requisite conditions of eligibility for promotion shall be promoted in preference to the senior official or officials.
- (iv) In rule 5 (**Qualification, Experience and Age Limit for Initial Appointment**), against S.# 8 under Column No.3 the word “**Matriculation**” shall be deleted and substituted by “**Intermediate / equivalent**”.
