No. F. 2(2)/2024-LGE-B(1).— In exercise of the powers conferred upon it under Article 140A(2) of the Constitution of the Islamic Republic of Pakistan, Sections-16(1) & 36 of the Balochistan Local Government Act, 2010 read with Rule-9 of the Balochistan Local Government (Election) Rules, 2013 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby fixes **4th April, 2024 (Thursday)** as the date for Local Government Bye-election to the seat of Chairman, Union Council No.24, District Mastung of Balochistan Province.

No. F. 2(2)/2024-LGE-B(3).— In exercise of the powers conferred upon it under Articles 140A (2) & 218(3) of the Constitution of the Islamic Republic of Pakistan read with Sections-6 & 193 of the Elections Act, 2017, the Election Commission of Pakistan hereby authorizes the Returning Officer /Presiding Officer, appointed for the conduct of Local Government Bye-election to the seat of Chairman, Union Council No.24, District Mastung of Balochistan Province, scheduled to be held on 04-04-2024 to exercise the powers of the Magistrate First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) for two days i.e 3rd & 4th April, 2024.

2. The aforesaid officer shall exercise the powers of Magistrate First Class under Section-193(a) of the Elections Act, 2017, Chapter-IV of the Balochistan Local Government Act, 2010 except the offence of corrupt practice provided in Section-46 of the *ibid*-Act. These offences shall be tried summarily in

terms of Section-193(b) of Elections Act, 2017, under the provisions of the Code of Criminal Procedure, 1898 (ACT No.V of 1898).
