2. TORs of the Committee shall be as under:

- a. Regularly monitor cotton prices in the main domestic markets of Punjab and Sindh as well as those in the international markets and issue a brief price report every week.
- b. The threshold intervention price of Seed-cotton is Rs. 5,700/40kg. When domestic prices of seed cotton drop below this threshold, trigger the intervention, to buy cotton lint of base grade-III at 10% discount of the estimated import parity price using Cotlook 'A' Index.
- c. Direct TCP when to procure cotton lint based on the methodology in (b) above and advise TCP when to sell procured bales by assessing the local and international cotton markets.
- d. Present a monthly report of the activities to ECC within 5 working days after the end of the calendar month.
- e. Submit a draft intervention price policy program report to ECC by 31st January 2023 and a final report by end of February 2023.
