Islamabad, the 1st April, 2022

S. R. O. 536(I)/2022.—WHEREAS, the Federal Government is of the opinion that employment in the Pakistan Petroleum Limited (PPL) is essential for uninterrupted supply of oil and gas by preventing any strike or untoward situation which may endanger the sensitive installations thus disrupting the supply of oil and gas which is essential for the benefit of the community.

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 3 of the Pakistan Essential Services (Maintenance) Act, 1952 (LIII of 1952), the Federal Government is pleased to declare all classes of employment in PPL to be the classes of employment to which the said Act shall apply for a period of six months with effect from 27-03-2022.
