**No.F.2(2)/2024-LGE(B)(VoL-I)(1).**— In exercise of the powers conferred upon it under Article 140A(2) of the Constitution of the Islamic Republic of Pakistan, Sections-16(1) & 36 of the Balochistan Local Government Act, 2010 read with Rule-9 of the Balochistan Local Government (Election) Rules, 2013 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby fixes **3rd July, 2024 (Wednesday)** as the date for Local Government Bye-elections to the seat of Chairmen, Union Council No.20 of district Dera Bugti and Union Council No.7 of district Kachhi of Balochistan Province.

**No.F.2(2)/2024-LGE(B)(VoL-I)(2).**— In exercise of the powers conferred upon it under Article 140A(2) of the Constitution of the Islamic Republic of Pakistan, Section 19 of the Balochistan Local Government Act, 2010 read with Rule 10 of the Balochistan Local Government (Election) Rules, 2013, the Election Commission of Pakistan hereby appoints the following officers as Returning Officers / Presiding Officers for the conduct of Local Government Bye-election to the seat of Chairmen, Union Council No.20 district Dera Bugti and Union Council No.7 district Kachhi of Balochistan Province;

**No.F.2(2)/2024-LGE(B)(VoL-I)(3).**— In exercise of the powers under section 193 of the Election Act, 2017 conferred upon it under Articles 140A (2) & 218(3) of the Constitution of the Islamic Republic of Pakistan read with Sections-6 & 193 of the Elections Act, 2017, the Election Commission of Pakistan hereby authorizes the Returning Officers / Presiding Officers, appointed for the conduct of Local Government Bye-election to the seats of Chairmen, Union Council No.20 district Dera Bugti and Union Council No.7 district Kachhi of Balochistan Province, scheduled to be held on 03-07-2024 to exercise the powers of the Magistrate First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) for two days i.e 2nd & 3rd July, 2024.

2. The aforesaid officer shall exercise the powers of Magistrate First Class under Section-193(a) of the Elections Act, 2017, Chapter-IV of the Balochistan Local Government Act, 2010 except the offence of corrupt practice provided in Section-46 of the ibid-Act. These offences shall be tried summarily in terms of Section-193(b) of Elections Act, 2017, under the provisions of the Code of Criminal Procedure, 1898 (ACT No.V of 1898).
