No. F.2(2)/2024-LGE-B (Vol-II)(2).—In exercise of the powers conferred upon it under Article 140A(2) of the Constitution of the Islamic Republic of Pakistan, Section 19 of the Balochistan Local Government Act, 2010 read with Rule 10 of the Balochistan Local Government (Election) Rules, 2013, the Election Commission of Pakistan hereby appoint the following officer as Returning Officer /Presiding Officer for the conduct of Local Government Bye-election to the seat of Chairman, Union Council No.34 Ahmedabad, District Usta Muhammad of Balochistan Province;

No.F.2(2)/2024-LGE-B(Vol-II)(3).—In exercise of the powers conferred upon it under Articles 140A (2) & 218(3) of the Constitution of the Islamic Republic of Pakistan read with Sections-6 & 193 of the Elections Act, 2017, the Election Commission of Pakistan hereby authorizes the Returning Officer /Presiding Officer, appointed for the conduct of Local Government Bye-election to the seat of Chairman, Union Council No.34 Ahmedabad, District Usta Muhammad of Balochistan Province, scheduled to be held on 31-07-2024 to exercise the powers of the Magistrate First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) for two days i.e 30th & 31st July, 2024.

2. The aforesaid officer shall exercise the powers of Magistrate First Class under Section-193(a) of the Elections Act, 2017, Chapter-IV of the Balochistan Local Government Act, 2010 except the offence of corrupt practice provided in Section-46 of the ibid-Act. These offences shall be tried summarily

in terms of Section-193(b) of Elections Act, 2017, under the provisions of the Code of Criminal Procedure, 1898 (ACT No. V of 1898).
