No. F.8(2)/2024-LGE-ICT.—In pursuance of the provisions of Articles 140(2) and 218 of the Constitution of the Islamic Republic of Pakistan, Section 6 (1) & 193 of Elections Act, 2017, Section-101 of the Khyber Pakhtunkhwa Local Government Act, 2013 read with Rule-2 of the Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules, 2021, the Election Commission hereby authorizes the Presiding Officers appointed at each polling station for the conduct of Local Government election to the vacant seat of Chairman, Tehsil Council Jamrud, District Khyber in Khyber Pakhtunkhwa (whereby poll shall be held on 25th September, 2024) to exercise the powers of Magistrate First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) from **24th to 26th September, 2024.**

The aforesaid officers shall exercise the powers of Magistrate First Class in respect of offences under Section-193(a)(b) of the Elections Act, 2017 and Chapter-XIV of the Khyber Pakhtunkhwa Local Government Act, 2013 and, all such offences shall be tried summarily under the Provisions of the Code of Criminal Procedure, 1898(Act No. V of 1898).

SUBJECT:— MAGISTERIAL POWERS TO DISTRICT RETURNING OFFICER AND RETURNING OFFICER APPOINTED FOR THE CONDUCT OF LOCAL GOVERNMENT ELECTION TO THE VACANT SEAT OF CHAIRMAN THE SIL COUNCIL JAMRUD, DISTRICT KHYBER IN KHYBER PAKHTUNKHWA PROVINCE.

No. F.8(2)/2024-LGE-KP.—In pursuance of the provisions of Article 140(2) and 218 of the Constitution of the Islamic Republic of Pakistan, Sections-06 & 193(a)(b) of Election Act, 2017 and Section-101 of the Khyber Pakhtunkhwa Local Government Act, 2013 read with Rule-2 of the Khyber Pakhtunkhwa Local Councils (Conduct of Election) Rules, 2021, the Election Commission hereby authorizes the District Returning Officer and Returning Officer appointed for the conduct of Local Government Election to the vacant seat of Chairman, Tehsil Council Jamrud, District Khyber in Khyber Pakhtunkhwa, whereby polling will be held on **25th September, 2024** to exercise the powers of Magistrate First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) with immediate effect till the announcement of official results.
