S. R. O. 1087(I)/2022.—The following draft of certain further amendments in the Drugs (Licensing, Registering & Advertising) Rules, 1976, which is proposed to be made in exercise of the powers conferred by section 23 of the Drug Regulatory Authority of Pakistan Act, 2012 (XXI of 2012), read with sub-section (1) of section 20, clause (d) of sub-section (1) of section 11 and clause (n) of section 7 thereof and section 43 of the Drugs Act, 1976 (XXI of 1976), is hereby published, as required by sub-section (3) of section 43, for the information of all persons likely to be affected thereby and notice is hereby given that objections or suggestions thereon, if any, may, for consideration, be sent within seven days of the publication of this Notification in the official Gazette.

Any objections or suggestions which may be received from any person in respect of the said draft, before expiry of the aforesaid period, shall be taken into consideration by the Drug Regulatory Authority of Pakistan.

4. In rule 19, sub-rule (5-A), the words “A fee of one thousand rupees”, the words “as notified by the Authority under the Drug Regulatory Authority of Pakistan (Levy of Fee and Charging) Rules, 2022” shall be substituted.
5. In rule 26, sub-rule (5), the words “A fee of rupees thousand”, the words “as notified by the Authority under the Drug Regulatory Authority of Pakistan (Levy of Fee and Charging) Rules, 2022” shall be substituted.
6. In rule 31, sub-rule (1-B), the words “fee specified in schedule F”, the words “as notified by the Authority under the Drug Regulatory Authority of Pakistan (Levy of Fee and Charging) Rules, 2022” shall be substituted.
7. In the aforesaid rules, Schedule F shall be omitted and schedule G will be renumbered as schedule F.
