**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE
COMPONENT OF TARIFF FOR JHIMPIR POWER (PVT.) LIMITED**

Pursuant to the indexations/adjustment mechanism stipulated in the decision of the Authority dated November 19, 2018 in the matter of tariff adjustment of Jhimpir Power (Pvt.) Limited (JPPL) at Commercial Operation Date (COD) notified in official gazette on March 21, 2019 vide S.R.O. No 399(I)/2019, the insurance cost and corresponding component of tariff of JPPL based on insurance cost for the period from March 16, 2021 to March 15, 2022 is given as under:

March 16, 2021 to March 15, 2022	66,281,550	0.4346

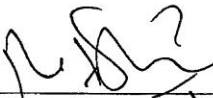
