- (a) In Rule-1 (Preamble) of the aforesaid recruitment rules, the words, '**Ministry of Education**' wherever occurring shall be substituted with the words, '**Ministry of Federal Education and Professional Training**'.

- (c) In Rule-1 (Preamble) of the aforesaid recruitment rules, the words, **‘National Education Management Information System (NEMIS)’** shall be substituted with the words, **‘Pakistan Institute of Education’**.
- (d) In Rule-1 (Preamble) of the aforesaid recruitment rules, the words, **‘National Education Assessment System (NEAS)’** shall be substituted with the words, **‘Pakistan Institute of Education’**.
