*Islamabad, the 4th August, 2022*

**SUBJECT:— ELECTION TO THE SEAT OF CHAIRMAN VC-07 SOSAK WHERE GENERAL COUNCILOR HAS BEEN ELECTED UN-OPPOSED IN 2ND PHASE OF LOCAL GOVERNMENT ELECTIONS IN KHYBER PAKHTUNKHWA.**

**No. F. 16(1)/2021-LGE-KP(Vol-I).**—In exercise of the powers conferred upon it under Article 140A(2) of the Constitution of the Islamic Republic of Pakistan, sub-section (1) of Section-75 and 86 of the Khyber Pakhtunkhwa Local Government Act 2013, read with Rule-77(b) of the Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules 2021, and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby fixes **16th August, 2022 (Tuesday)** as the date for the conduct of election to the seat of Chairman of **VC-07 Sosak District Kohistan Upper** and calls upon the Members/Electoral College of following council to elect Chairman of their respective council:

2. The Election shall be conducted in accordance with the procedure provided in Chapter-VIIA of the Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules, 2021 and as per instructions of the Commission.

3. The Returning Officer appointed *vide* this Commission Notification No.F.7(2)/2022- LGE-KP dated 4th August, 2022 shall call the meeting of Village Council and inform all the Returned Candidates of the concerned Council before election day, clearly intimating the date, place and time of the meeting. The date of the meeting shall be **16th August, 2022** *i.e.* Election Day.

4. The nomination Form-XXVI attached with the Khyber Pakhtunkhwa Local Councils. (Conduct of Elections) Rules, 2021 shall be used for filling of nomination papers by the contesting candidates.

5. The Returning Officer shall keep record of the proceedings.

6. All the activities of election *i.e.* Filling of Nomination, Scrutiny of Nomination Papers and Withdrawal of candidature shall be completed on the same day as fixed for the election *i.e.* **16th August, 2022**.

7. Election Hours will be observed from **2:00 PM to 5.00 PM**.
