S.R.O. 1750(I)/2022.— In exercise of the powers conferred by section 176A of the Pakistan Army Act, 1952 (XXXIX of 1952), the Federal Government is pleased to direct that the following further amendments shall be made in the Scales of Rations and Supplies (Regulations) 2015, namely:—

In the aforesaid Regulations:—

- (1) in Annex-A, relating to Regs-11, in the Table of basic scale of rations for troops, in column (1), -----
 - (a) against S. No. 1, against the entry “Atta”, in column (2), for the entry in column (3), the figure “650” shall be substituted;
 - (b) against S. No. 2 for the entry in column (3), the figure “80” shall be substituted;

- (c) against S. No. 4, against the entry "Milk Powder Whole" in column (2), for the entry in column (3), the figure "45" shall be substituted;
 - (d) against S. No. 5, for the entry in column (3), the figure "62" shall be substituted;
 - (e) against S. No. 7, for the entry in column (3), the figure "214" shall be substituted;
 - (f) against S. No. 8, for the entry in column (3), the figure "65" shall be substituted;
 - (g) against S. No. 10, for the entry in column (3), the figure "7" shall be substituted;
 - (h) against S. No. 12, for the entry in column (6), the expression "6 (regular 4 issues per month not exceeding 6 issues) shall be substituted;
 - (i) against S. No. 13, against the entry "Beef" in column (4), for the entry in column (5), the figure "180" shall be substituted; and
 - (j) against S. No. 13, against the entry "Beef" in column (4), for the entry in column (7), the expression "reduction of beef from 9 to 7 issues per month" shall be substituted; and
- (2) in Annex A, relating to Regs-11, in the Table of basic scale of rations for troops, in column (1), after S. No. 13 and entries relating thereto in column (2) to (9), the following New S. Nos. and corresponding entries thereto shall be inserted, namely:—
