**DECISION OF THE AUTHORITY IN THE MATTER OF INDEXATION/ADJUSTMENT for
Jul-Dec 2022 OF TRANSMISSION TARIFF FOR SINDH TRANSMISSION & DISPATCH
COMPANY (PRIVATE) LIMITED**

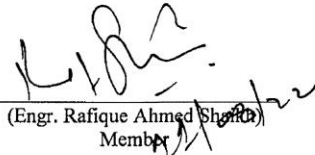
1. Pursuant to the decision of the Authority dated February 10, 2017 for determination of transmission tariff for Sindh Transmission & Dispatch Company (Private) Limited (hereinafter "STDC") for 132 kV Transmission Line Project and decision of the Authority dated June 14, 2018 for Motion for Leave for Review, the tariff of STDC for the period July to December 2022 has been revised on account of NCPI (Local) and KIBOR variation in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised components are indicated hereunder and shall be applicable for the particular period as mentioned below:

Tariff Components (Rs.kW/Hr)	Reference Tariff	Revised Jul-Dec 2022
O&M	0.1824*	0.2211
Insurance	0.0192	0.0192
Debt Service	0.2127	0.2963
Return on Equity	0.0935	0.0935
Total	0.5078	0.6301

*For O&M indexation of Jul-Dec-2022, NCPI of December 2019 (130.45) has been used.

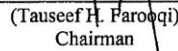
2. The Authority vide its decisions dated September 21, 2021 have revised the net capacity for (SNPC-1) & (SNPC-2) to 51.154 MW and 51.526 MW respectively. Accordingly, on the basis of revised net capacity, the debt servicing component has been revised.
3. The indexation/adjustment is allowed to STDC on provisional basis till finalization of COD decision and subject to refund/adjustment, if necessary, in light of final decision of the Authority.
4. The revised tariff components attached as Annex-I are to be notified in the official gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.

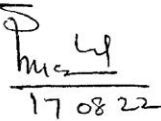
