SUBJECT:— **ELECTION TO THE SEAT OF CHAIRMAN VC-18 ROI BAIK DISTRICT KOHISTAN UPPER WHERE GENERAL COUNCILOR HAS BEEN ELECTED UN-OPPOSED IN 2ND PHASE OF LOCAL GOVERNMENT ELECTIONS IN 18-DISTRICTS OF KHYBER PAKHTUNKHWA**

No. F. 16(1)/2021-LGE-KP(Vol-I).—In exercise of the powers conferred upon it under Article 140A(2) of the Constitution of the Islamic Republic of Pakistan, sub-section (1) of Section-75 and 86 of the Khyber Pakhtunkhwa Local Government Act 2013, read with Rule-77(b) of the Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules 2021, and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby fixes **27th September, 2022 (Tuesday)** as the date for the conduct of election to the seat of Chairman of **VC-18 Roi Baik District Kohistan Upper** and call upon the Members/Electoral College of above Village Council to elect Chairman of their respective Village Council:

2. The Election shall be conducted in accordance with the procedure provided Chapter-VIIA of the Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules, 2021 and as per instructions of the Commission.

3. The Returning Officer appointed *vide* this Commission Notification No.F.7(2)/2022-LGE- KP dated 22-06-2022 shall call meeting of Village Council-18 Roi Baik under his jurisdiction and informed all the Returned Candidates of the Village Council before election day, clearly intimated the . date, place and time of the meeting. The date of the meeting shall be **27th September, 2022** *i.e.* Election Day.

4. The nomination Form-XXVI attached with the Khyber Pakhtunkhwa Local Councils, (Conduct of Elections) Rules, 2021 shall be used for filling of nomination papers by the contesting candidates.

5. The Returning Officer shall keep record of the proceedings.

6. All the activities of election *i.e.* Filling of Nomination, Scrutiny of Nomination Papers and Withdrawal of candidature shall be completed on the same day as fixed for the election *i.e* **27th September, 2022**.

Election Hours will be observed from **02:00 PM to 05.00 PM**.
