O. 2005(I)/2022.—In pursuance of sub-rule (2) of Rule-3 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973 and Section 7(1) (b) (i) and (ii) of Federal Public Service Commission Ordinance, 1977 (XLV of 1977), the following amendments shall be made in the Recruitment Rules of National Library of Pakistan under the National Heritage and Culture Division, notified *vide* SRO. 1199(1)/2019, dated 07.10.2019, namely:—

- (b) In Rule-3 (Conditions for promotion) under column (3) against the post at Sl. No. 1, the existing entries shall be substituted with **“Director (HRDC) (BS-19)/ Director (Technical) (BS-19)”**.
- (c) In Rule-3 (Conditions for promotion) under column (4) against the posts at S 1 .Nos.1, 2 and 3, the existing entries shall be substituted as under:—

- (d) In the Schedule (See Rule-4) under column-3, against the post at Sl. No.16, the words, brackets and figure, **“or Bachelor’s (4 years duration)”** may be added after the words and figure, **“2”d Class or Grade ‘C’ Master’s”**.

- (e) In Schedule (See Rule-4) against Sl.No.6 under column 3 the word “**equivalent**” may be added after the words “Information Technology or”.
