No. F. 1(9)/2022-By-Elections.—In pursuance of Article 218(3) of the Constitution of Islamic Republic of Pakistan, it is the duty of Election Commission of Pakistan to organize and conduct election and to make such arrangements as are necessary to ensure that the election is conducted honestly, justly, fairly and in accordance with law and that, corrupt practices are guarded against, Constituency wise breakup is as under:—

2. The Election Commission of Pakistan in terms of **Article, 220** of the Constitution, section **5** read with section **193** of the **Elections Act, 2017 (XXXIII of 2017)**, hereby authorizes that each designated officer in-charge of [Pakistan Rangers (Punjab & Sindh), Frontier corps (Khyber Pakhtunkhwa)(QRF mode only as 2nd tire responder) Pakistan Army troops] deployed for providing security, as QRF mode(insitu/fwd placed as decided by MO Dte as 3rd tire responder) and Frontier Constabulary as 1st tier responder outside the polling stations, from **15th October to 17th October, 2022**. on above-said constituencies for peaceful and smooth conduct of poll of the constituencies shall exercise powers of Magistrate First Class for entire duration of their deployment in respect of offences mentioned in section **171** (capturing of a polling station or polling booth) punishable under section **174** of the aforesaid Act and to take cognizance of any such offences under section **190** of the Code of Criminal Procedure and to try such offences in a summary way in accordance with the provisions of the said Code relating to summary trials.

3. The security personnel of **[Pakistan Rangers (Punjab & Sindh), Frontier corps (Khyber Pakhtunkhwa), Pakistan Army troops and Frontier Constabulary]**, while performing their security duties are supposed to first report to the Presiding Officer any irregularity or malpractice, they observe outside the polling station and act according to the instructions issued by him in that regard. In case, the Presiding Officers does not act to prevent the commission of any reported irregularity or malpractice, the security staff will immediately bring the matter to the notice of the designated officer-in-charge of **[Pakistan Rangers (Punjab & Sindh), Frontier corps (Khyber Pakhtunkhwa), Pakistan Army troops and Frontier Constabulary]** of an area of the said constituencies for action in light of the powers delegated to him under para-3 above and also inform Returning Officers concerned.
